Notes of precautions about use of After school Open Square are as follows.
Before applying, all items should be confirmed and agreed.

1	After school Open Square is made by opening a part of school facilities to the students for after school, on Saturday and during the three seasons holiday period as an attending place where children can play and learn freely by thinking of themselves just like going to a park to play. The staff will encourage children to exercise their spontaneity and independence, watch over their independent activities, talk to them and support. It is different from the Room for Association of Children of a Family away from home where childcare and keep children are made.
2	Please discuss carefully with your child at home and decide how to spend time in After school Open Square, at what time come back to home and how safe it is to come and go and then use it at each family' s responsibility.
3	If a child is injured, we will provide simple first aid, but depending on the situation we may contact the parents and ask them to pick their child up or transport their child to the hospital. If an emergency is required, an ambulance will be requested.
4	Registration and participation are free of charge. In order to use After school Open Square safely, 1,000 yen per person per year is necessary as burden of actual cost of accident insurance, etc. Regarding the compensation for injuries that occur during activities, we will first ask the parents to bear the cost, and then proceed to the insurance procedures. (Depending on the accident, it may not be covered by the insurance.) Once paid, the insurance premiums will not be refunded under any circumstances regardless whether they are used or not.
5	When children bring lunch boxes, the parents are responsible for hygiene considerations (use of ice packs) and considerations for storage of lunch boxes, food allergies, etc.
6	If a child does not follow staff' s instructions and commits dangerous behavior such as human rights violation, violence・nuisance, etc. , we may refuse to use the facility in the future.
