

By integrally operating the \[ \text{Room for Association of Children of a Family away from home} \] and newly established \[ \text{After school Open Square} \] by opening a certain place of school for after school where all children can play voluntarily and freely, we will provide all children with an attending place where they can spend their time safely and peacefully and adjust an environment where their parents can make choice of two projects according to their needs. After pre-registration, any students of elementary school living or attending the school in the city can freely participate After school Open Square free of charge (insurance premiums, etc. may be required).

Project content	The dedicated room of Room for Association of Children and the place of implementation of After school Open Square (utilizing extra classrooms and special classrooms) will be the bases for each activity and the library, schoolyard and gymnasium will also be used according to needs. Also, depending on the number of participants, activities will be held in a designated dedicated room of Room for Association of Children.  **Operation will also be done in existing classroom for each time shift in addition to vacant classroom.		

# Point ①

#### Difference between To keep and Voluntary attending place

「Room for Association of Children of a Family away from home」 is **a place to keep** children where provide appropriate play and living places with children who need childcare. 「After school Open Square」 is **a voluntary attending place** where adults watch, talk to children and support the voluntary activities of children who wish to participate.

# Point 2

#### Integrated operation

「Room for Association of Children of a Family away from home」 and 「After school Open Square」 will be operated by the same project operator or the city collectively so that we can unify the contact point and provide more polite support with the participating children such as understanding whereabout of the children, etc. Participating children to both projects can play together during the time shift of opening room.

Guidance of starting date of use will be approximately 2 weeks after for electronic application and 3 weeks after for application by documents. \* 2 Application by documents for children registered in Reiwa 5th year can be done only at the window of division of children after school (1-1-1 Kurumazuka Hirakata-Shi 4th floor Kagayaki Plaza) and for children registering for the first time in Reiwa 6th year can be done at the window of division of children of after school, each room of children of family away from home and place executing open square. Application can't be accepted at primary school.

## Precautions for use of After school Open Square

After school Open Square is made by opening a part of school facilities to the students for after school, on Saturday and during the three seasons holiday period as an attending place where children can play and learn freely by thinking of themselves just like going to a park to play. The staff will encourage children to exercise their spontaneity and independence, watch over their independent activities, talk to them and support. It is different from the Room for Association of Children of a Family away from home where childcare and keep children are made.

After school Open Square does not control children's time schedule. Please discuss carefully with your child at home and decide how to spend time in After school Open Square, at what time come back to home and how safe it is to come and go and then use it at each family's responsibility.

If a child is injured, we will provide simple first aid, but depending on the situation we may contact the parents and ask them to pick their child up or transport their child to the hospital. If an emergency is required, an ambulance will be requested.

Although cost of use is free, there is a charge of 1,000 yen at the time of registration. (It will be used for accident insurance premium, shipping cost and a part of the cost of the toys etc. used by children). Regarding compensation for injuries during activities, first the cost will have to be charged by parents and then process to get insurance will be executed. (It may not be covered by insurance depending on accident.) 1,000 yen charged at the time of registration will never be refunded at any time regardless whether it is used or not.

When bringing lunch boxes, the parents are responsible for hygiene considerations (use of ice packs) and considerations for storage of lunch boxes, food allergies, etc.

If a child does not follow staff's instructions and commits dangerous behavior such as human rights violation, violence • nuisance, etc., we may refuse to use the facility in the future.

After school Open Square is not operated by the school, so please contact the Division of Children after school for inquiries. Please refrain from contacting the school.
